INSTRUCTIONS

Zoning prescribes what kinds of uses are allowed on a particular piece of property and is a tool that implements the long-range plan for the City of Wagoner pursuant to the City of Wagoner Comprehensive Plan.

Time for Filing

Each application shall be filed with the Planning Commission at least thirty (30) days prior to the date of the public hearing at which it is to be considered.

Filing Fee

Residential—\$200

Office, Commercial, Industrial, Mixed Use-\$300

Notice

Notice shall be published in a newspaper of general circulation in the City of Wagoner at least one (1) time, fifteen (15) days prior to the hearing date. Written notice must be sent at least twenty (20) days prior to the hearing date and be sent to all owners of real property included in the proposed change and all owners of real property within a three hundred (300) foot radius of the exterior boundary of the property. Notice shall be given by posting a sign on the subject property at least (20) days prior to the public hearing date.

Affidavit of Mailing

An Affidavit of Mailing, prepared by a licensed abstractor, shall be filed with the Planning Commission prior to the public hearing date. Failure to file the Affidavit of Mailing within the allotted time, or if the mailing list is found to be incorrect, may be grounds for the Commission to deny the application.

Meeting

Regular meetings for the Wagoner Metropolitan Planning Commission are held on the last Tuesday of each month. The meetings are called to order at 6:00 P.M., at the Wagoner Civic Center, located at 301 S Grant Avenue, Wagoner, OK.

Planning Commission Approval

If the Planning Commission recommends approval of the application for zoning change, it will be forwarded to the next regularly scheduled City Council meeting.

Planning Commission Denial

If the Planning Commission denies the application, the applicant may appeal the Commission's decision to the City Council. To appeal, the applicant must file a written request with the City Clerk within ten (10) days from the date of Planning Commission's action.

Other Information

Site plans, photographs, and other factual information and evidence which will help the Planning Commission reach an intelligent decision must be attached to the application at the time of filing.



Lettering of the sign shall be in 2-inch black letters.

Signs shall be posted 20 days before the date of the public hearing date. Signs shall be posted in a clear opening on a building or post not less than 12 inches nor more than 48 inches from the ground on or inside the property line no more than 30 feet.

The sign shall be in full view from a public street or streets toward which it faces.
