This report form permits you to easily report a crime in which you are the victim.

This report will be reviewed by a Police Officer.

If any other information is needed the Wagoner Police Department will contact you.

You may only use the citizen crime report if you are reporting one of the following crimes:

- Larceny (under \$500.00)
- · Lost Property or supplemental loss for an existing report
- · Malicious Mischief / Vandalism
- · Harassing / Threatening / Obscene Phone Calls
- · City Misdemeanors

You may not use this report for domestic violence assault; hate crimes, or firearm complaints. Burglaries, Robberies, Rapes etc. should be reported directly to the Wagoner Police Department.

Bogus Check, Forged Check, and Embezzlement reports can be made in person at the Wagoner Police Department. 105 South Casaver Avenue. This report cannot be used because physical evidence must be provided at the time of the report.
